International students enrolled in English language programs (ELP) at U.S. colleges and universities contribute **\$371.3 million** to the U.S. economy and support **2,691 jobs.\*** For every three international students enrolled in a college or university ELP, **one U.S. job is created** and supported by spending occurring in the higher education, accommodation, dining, retail, transportation, telecommunications and health insurance sectors.

International students studying at colleges and universities across the United States contribute **\$43.8 billion** to the U.S. economy and support **378,175 jobs**. The economic contributions of international students are in addition to the immeasurable academic and cultural value these students bring to our campuses and local communities.
